Procurement - a reminder re deliveries to home addresses

When raising purchase orders for the delivery of items to alternative or home addresses users are reminded of the need to be careful and to please check beforehand that the supplier can accommodate this and **only raise non-catalogue orders** that detail the alternative address (please see <u>previous guidance</u>). It is frustrating for suppliers, especially during these difficult times, to arrive at University buildings to find that they are closed . Not only does this mean that they are unable make the delivery but the associated increased handling is resulting in increased demands on their own workforce.

AP: Procedures for converting cheque payments to BACS payments

As previously advised no further cheques runs will be produced given the issues of producing, posting, receiving and banking of them. Instead the Finance Division will manage the process of paying all supplier types by BACS. Attached are the procedures relating to:

- Setting up new and existing trade suppliers for BACS payments
- Setting up new and existing individuals and students so we can pay them by BACS
- What to do if a payee has not received or, is unable to bank , their previously issued cheque

These procedures are especially relevant to departments who are not currently using Shared Services for their processing.

The CUFS system will be unavailable during the vulnerable period of 6am to 9.30am on Thursday 16th April. This time will be used for system maintenance.
